3. 4 installments of \$113.00. Each payment (November 15th, February 15th, May 15th, and August 15th) will be automatically billed to your credit card and must be on auto-renewal. **Please note this option is available for payment by credit card only. You must sign up for this option by November 15th. This payment option will not be available after November 15th.**
